### DECLARATION OFFICIALS/PLAYERS

- As a participant in this FIVB/World competition and, in consideration of the acceptance of my participation therein, I declare that I will respect the spirit of fair play, clean game and non-violence, and behave accordingly on and off the sports field.
- 2. I declare that I have read and that I have full knowledge of the provisions of the FIVB Constitution and the FIVB Regulations (fivb.org) currently in force and I agree to comply with all such provisions. In particular I agree to comply with the provisions of the FIVB Medical Regulations regarding Anti-Doping currently in force and I hereby confirm that I am aware of the regulations and penalties relating to the fight against doping.
- 3. [Applicable only to players] I agree to submit to the doping control tests (including out of competition tests by FIVB, WADA or any organisation commissioned by FIVB or WADA), to accept the results of such tests and to abide by the respective regulations as applicable from time to time. I also agree that my National Federation and my club forward my personal data to FIVB for use in connection with doping control tests, results management and possible disciplinary proceedings. I hereby consent to the processing of my personal data in accordance with the applicable anti-doping regulations of FIVB and WADA.
- 4. I agree to be filmed, televised, photographed, identified and otherwise recorded by FIVB and I hereby consent that my name, likeness, autograph and other identifying characteristics may be used in connection with the production, sale, distribution, development, advertising and promotion of any FIVB or FIVB-licensed communication, product or service, but excluding the use which implies endorsement by me of any other commercial entity, product or service. I may not display (including on any clothing) any third party commercial identification or branding in any FIVB/World Competition hall or training ground of the competition or at any official FIVB press conference other than manufacturer's identification in accordance with the FIVB Regulations.

- 5. I also agree to comply with the FIVB Code of Conduct and the IOC Code of Ethics, in particular not to participate in, support or promote betting activities related to FIVB competitions. I further agree that third parties are allowed to transfer to FIVB information pertaining to betting activities in relation to the FIVB competitions.
- 6. I acknowledge and agree that:
  - a. I participate in this FIVB/World competition at my own risk and I agree that I will take all reasonable measures to protect myself from the risks of participation;
  - b. I am responsible for all property I bring into the competition sites and that the Organizing Committee and FIVB shall have no responsibility for any loss or damage to this property.
- 7. I irrevocably release the Organizing Committee and FIVB (and their respective members, directors, officers, employees, volunteers, contractors or agents) from any liability (to the extent permitted by law) for any loss, injury or damage that I may suffer in relation to my participation in the FIVB competition.
- 8. I agree that any dispute, controversy or claim arising out of, in connection with, or on the occasion of this FIVB/World competition and/or generally the FIVB Constitution and Regulations, which cannot be settled amicably and which remains unsettled once the legal remedies established by the FIVB Constitution and Regulations have been exhausted, shall be submitted exclusively to the Court of Arbitration for Sport (CAS) for final and binding arbitration in accordance with the Code of sports-related Arbitration. The arbitration shall be conducted in English, be governed by Chapter 12 of the Swiss Act on Private International Law and its seat shall be in Lausanne, Switzerland. The decisions of the CAS shall be final, binding and non-appealable. I shall not and I hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.
- I acknowledge and agree that my participation to this FIVB/World competition is conditional upon my valid acceptance of and my compliance with each and all the provisions of this entry form.
